ORDER EXPUNGING CRIMINAL RECORDS

THIS CAUSE having come to be heard before me this date upon a Petition to Expunge certain records of the petitioner's arrest on January 28, 2008, by the Hillsborough County Sheriff's Office, for the charges of misdemeanor battery (domestic violence) and felony obstructing justice (tampering with a witness), and the Court having heard argument of counsel and being otherwise fully advised in the premises, the Court hereby finds the following:

1. The petitioner has never previously been adjudicated guilty of a criminal offense or a comparable ordinance violation nor adjudicated delinquent for committing a felony or a misdemeanor specified in section 943.051(3)(b), Florida Statutes.
2. The petitioner was not adjudicated guilty of nor adjudicated delinquent for committing any of the acts stemming from the arrest or criminal activity to which the instant petitioner pertains.
3. The petitioner has not secured a prior records expunction or sealing.
4. An indictment, information, or other charging document filed against the defendant was dismissed by the prosecutor on July 10, 2008 by Notice of Nolle Prose.
5. A Certificate of Eligibility issued by the Florida Department of Law Enforcement accompanied the petition for expunction of non-judicial criminal history records.

ORDERED AND ADJUDGED that the petition to expunge is hereby granted. All court records pertaining to the above-styled case shall be sealed in accordance with procedures set forth in Florida Rule of Civil Procedure 3.692; and it is further

ORDERED AND ADJUDGED that the clerk of this court shall forward a certified copy of this order to the State Attorney, Hillsborough County Sheriff's Office, and the Sheriff of Hillsborough County, who will comply with the procedures set forth in section 943.0585, Florida Statutes, and appropriate regulations of the Florida Department of Law Enforcement, and who will further forward a copy of this order to any agency that their records reflect has received the instant criminal history record information; and it is further

ORDERED AND ADJUDGED that Hillsborough County Sheriff's Office shall expunge all information concerning indicia of arrest or criminal history record information regarding the arrest or alleged criminal activity to which this petition pertains in accordance with the procedures set forth in section 943.0585, Florida Statutes, and Florida Rule of Criminal Procedures 3.692.

All costs of certified copies involved herein are to be borne by the petitioner.

ORDER EXPUNGING CRIMINAL RECORDS

THIS CAUSE having come to be heard before me this date upon a Petition to Expunge certain records of the petitioner's arrest on January 28, 2008, by the Hillsborough County Sheriff's Office, for the charges of misdemeanor battery (domestic violence) and felony obstructing justice (tampering with a witness), and the Court having heard argument of counsel and being otherwise fully advised in the premises, the Court hereby finds the following:

1. The petitioner has never previously been adjudicated guilty of a criminal offense or a comparable ordinance violation nor adjudicated delinquent for committing a felony or a misdemeanor specified in section 943.051(3)(b), Florida Statutes.
2. The petitioner was not adjudicated guilty of nor adjudicated delinquent for committing any of the acts stemming from the arrest or criminal activity to which the instant petitioner pertains.
3. The petitioner has not secured a prior records expunction or sealing.
4. An indictment, information, or other charging document filed against the defendant was dismissed by the prosecutor on July 10, 2008 by Notice of Nolle Prose.
